VORP does two different types of case. The traditional VORP case is for juvenile offenders charged with misdemeanors. The joint meeting a mediator leads in those cases usually includes the offender and parents, the victim and maybe a support person for the victim. The other type of case is the Community Justice Conference. These cases involve felonies and a much larger group of participants in the joint meeting. Rick Gaston and I are working a CJC case right now where there will probably be 30 people in the meeting, including a Deputy District Attorney, two defense attorneys, a probation officer and two police officers. The offenders in this case have numerous felony charges.

We are in the process of preparing more of our mediators to handle these more complex CJC cases which can be very time consuming and require the mediator to have a high level of comfort with the process. If you are one of our experienced mediators and are interested in working with CJC cases, give us a call.

At our last mediator training people were surprised, as usual, to discover that most of VORP's income comes from individuals and churches. It was a good reminder for me that we are peculiar in this way. Thanks to you for helping us to stay that way.

Mediator Interview with Renee Soto

Renee Soto has been a VORP volunteer mediator since 2002. She first learned about VORP while working on her concentration area in the Masters Program of Peacemaking and Conflict Studies at Fresno Pacific University. She was required to mediate VORP cases for a class and has had good experiences with the program. Renee believes that the way VORP teaches minors to deal with conflict is a needed tool in the Juvenile Justice System. In her opinion, it would be ideal if this alternative Restorative Justice program was the first option in all juvenile offender cases. Renee says community members, especially parents, should be more informed about VORP. She finds that Community Justice Conference (pre-sentencing) cases are very rewarding. In her last case, the offenders were happy with the outcome of the agreement, the victim was also pleased, experienced emotional recovery and reconciliation took place at the mediation.

Renee works as a Field Compliance Coordinator with an insurance company. Even at her workplace, she is able to use the communication skills and ways to deal with conflict she has learned through VORP.
