In September 2002 the Center for Peacemaking and Conflict Studies of Fresno Pacific University was given the responsibility for administering VORP. Ron Claassen, Director of the Center, worked at long Range issues and Duane Ruth-Heffelbower became the administrator in charge of day to day operations. The administrative arrangement with the Center for Peacemaking continues as responsibilities are changed.

On September 27 Noelle Daoudian, VORP's Media-tion Manager, became the Program Director of VORP. Johnny Phouthachak continues as Agreements Manager. Ron Claassen, as Director of the Center for Peacemaking and Conflict Studies, will continue to provide support to Noelle and Duane Ruth-Heffelbower, who chaired the Board at the time of VORP's incorporation in 1985, will continue as a consultant.

Kingdom Work

During the summer of 2006 I took a weekend refresher course for volunteer mediators taught by long-time mediator Tony Redfern. The sessions were held at the College Community Church, Mennonite Brethren—the church where I am a member. We were experimenting with the idea of becoming a church-based VORP site and I was interested in upgrading my mediation skills. Years ago when I was a seminary student, I had taken the VORP course and mediated a case. Already at that time I had been impressed by the program and its potential for dealing with conflict and for helping people develop healthy ways of communicating.

After the mediator training last summer, I agreed to take a case. Unfortunately, after working with both parties extensively, I was unable to bring them to the negotiating table. There was a high degree of mistrust and I could not persuade the parties to meet face-to-face. The case went back to the probation officer. Following this disappointing experience, I discussed the case with more experienced mediators at the VORP office and realized that there were a few things that I could have done differently. I resolved to try again the following year.

In July 2007 I called the VORP office asking if there was a case for me to mediate. I wanted to try again. The case I was given involved a family dispute together with theft and vandalism. As I met with both parties, I was saddened by the stories of pain, rejection, intimidation, and loss. However, this time I was able to get both parties to come together. We met in the Fellowship Hall at College Community Church. There were tears and hard things said, but the meeting went very well. In the face-to-face meeting between the victim and the offender something very special happened! Both parties were able to hear each other speak about the event and its impact on others. Apologies were given, community service hours were assigned, counseling was scheduled, and promises were made to address some of the family system needs and to make things better. I drove home from the meeting very encouraged! For me this was a profound demonstration of God's kingdom work in the lives of real families. *

Case Update as of September 2007

Our caseload total of 480 cases is a little lower than last year , but this is mostly due to a decrease in box cited cases with only 272 cases referred. However, our standard cases with a probation officer have held strong with 208 cases referred. We have a total of 93 agreements for the year, which is on target and we are expecting a couple more soon!

We have 198 cases currently in process, most have a mediator, but we always have cases that are ready to be picked up by our mediators. So if you would like to take a case call our office and we'll get one to you.
