The 2nd Annual California VORP Gathering will be meeting Oct 5 in Fresno. All VORP program leaders and others interested in VORP are invited. The registration fee is \$10 and scholarships are available. If you are interested, you are welcome. Call Shannon at 291-1120 for details. Dan Van Ness, President of Justice Fellowship (Sister organization to Prison Fellowship - both associated with Chuck Colson), will be our guest speaker. Dan is a strong advocate of VORP as one of the ways of moving the Theory of Restorative Justice into practice.

Dan will also be speaking twice on Oct 4. At 8:00am in the College Community Mennonite Brethren Church fellowship hall he will be speaking to pastors and others interested from the church community. Coffee and rolls will be served. A no-host lunch is being co-sponsored by VORP and the Fresno Human Relations Commission. The invited group will be Fresno's leaders responsible for our Criminal Justice System. The focus in both meetings will be Restorative Justice (Crime Harms - Justice Restores).

We will also be traveling to Vacaville to introduce Dan to VORG, Victim Offender Reconciliation Group, which is a group of inmates meeting to sensitize themselves to the impact of their crimes on victims and to do constructive acts working at reconciliation. On Sept 12 I will be speaking/working with them on cooperative ways of resolving disputes. On Oct 3 Dan will be speaking to them on the topic of Restorative Justice (Crime Harms - Justice Restores).

David Janzen VORP volunteer mediator from Bethany Mennonite Brethren Church and a computer programer, is sharing a recent VORP experience with us which illustrates restorative justice. Some names and details have been changed to protect identities.

There is a healing process that takes place over the course of a meeting between victim and offender that, as the saying goes, must be seen to be appreciated.

When I first met with Richard, he seemed anything but excited at the thought of meeting with the boys who, 3 weeks earlier, had sent rocks through the window at the rear of his house. All he wanted was his \$80 in the mail and, hopefully, never again see the kids who had done this to him and his wife. There was a part of me that wanted to describe the good things that happen when victims meet face-to-face with offenders. A part of me also knew that he probably would not want to hear that at the present moment. I asked him if he would at least be willing to let the families drop off their respective shares of the \$80 in person. He thought that would be fine.

In talking with both Steven and Robert (and their families), the one thing both had in common was that they were quite apprehensive about meeting Richard. Both knew he was quite upset about what had happened, and both thought it best if I just delivered the checks to Richard myself. To walk the two blocks back to Richard's place with checks in hand, would have seemed easy enough. Richard would have been compensated for the damage to his house and the whole matter would be finished.

But such a solution could hardly be called reconciliation. They agreed to walk over to Richard's with me the next day and deliver the checks in person.

I think that many times the VORP mediator has only to get the people together in order for the reconciliation process to happen. What happened, and quite spontaneously, was the 9 of us sitting down in the living room, and both victim and offenders sharing their feelings about what had happened. Richard began by expressing how scared he and his wife had been when the rocks came crashing through their window. He told about how he was

It was obvious that the still scared at the thought of it happening again. two boys had no idea that what they had done had caused so much anguish. Together, they both told Richard how sorry they were and most importantly, that it would not happen again. Richard said he admired the families, and in particular the two boys, for coming over and speaking to him. Soon the conversation drifted into what the boys were doing in school, and how much Richard and his wife enjoyed golf. What might have been just 2 checks in the mail, for a brief meeting at the door, became a 1/2 hour visit in (60 Richard's house and one in which things were truly made right. * All involved said how glad they were to have met face-to-face, and that they work felt the whole thing was really behind them now! or or or the
