

CLARIFICATION OF WHAT RON REALLY DOES:

There are probably some of you who have heard that Ron Claassen, who is the VORP Director, is also now employed by Fresno Pacific College. Or possibly you heard he will be teaching a course at the Mennonite Brethren Seminary one week in January or is developing conflict manager programs in schools. All of these statements are true, but might be a bit confusing also.

So, we asked him, "Ron, what do you really do?" And this was his response:

"I am now employed full time by Fresno Pacific College as Co-Director of the Center for Conflict Studies and Peacemaking (CCSP). VORP contracts with CCSP for two days a week of my time (same time and cost as before) to continue as Director of VORP. My other priorities are: 1) training and program development for conflict manager programs in schools, 2) training for leaders in churches (January 14-18 at the Mennonite Brethren Seminary) and 3) involvement as mediator in a variety of conflict situations. There is no change in my time devoted to VORP."

Thanks for the clarification Ron!


JUST ARRIVED!!
