VORP continues to develop in new areas. We continue to work with our Expansion/Consultation program now called Restorative Justice Ministries through Fresno Pacific College

We arranged and hosted the Seventh Annual California VORP Gathering. We arranged and hosted the Second Annual Restorative Justice Ministries Conference.

The 300 page "Church Based VORP-Organizing/Program Manual" was completed and is now available.

"Starting a Church Based VORP" is a three day workshop designed to provide training on developing and maintaining a Church Based VORP. Participants the two workshops offered in 1994 included people from Texas, Ohio, Pennsylvania, Singapore, and several counties in California. The expansion and support activity is funded in part by Mennonite Central Committee-West Coast, Mennonite Conciliation Services, and MCC Office of Crime and Justice.

# Mediation can lead to respect forgiveness – reconciliation

CAN WE RESPOND CONSTRUCTIVELY? A crime incident happens when a person

disrespects other persons and/or their property. Crime is wrong. It shouldn't happen. When it does happen, the question then becomes, what is an appropriate response?

#### DANGER AND OPPORTUNITY

The situation now presents both dangers and opportunities. The danger is that no action is taken, or that the action taken continues and escalates the disrespect – for the victim(s) and now perhaps also for the offender. The opportunity is that action can be taken to recognize the disrespect and its impact, that steps can be taken to restore the damage and learn respect, and that increased respect can prevent future occurrences of disrespect.

VORP mediators are community volunteers trained to invite and encourage the offender and victim to decide individually if they are willing to look for a constructive resolution to the conflict and, if they are willing, to lead in a forgiveness/reconciliation process:

### **VORP** relies entirely on your contributions!

- (1) recognize the injustices (tell/listen/summarize the events and impact in the violation and offender accepting responsibility);
- (2) restore the equity or balance between them as much as possible (agree on what can be done to make things as right as possible now - realizing that to some extent this is always symbolic, restoring equity is a combination of restitution and grace); and
- (3) establish commitments for a safer, more just future (give assurances and take steps to prevent the injustice from happening again).

#### FROM INCREASING HATRED TO INCREASING CARE

I think of reconciliation as being movement along a continuum from increasing hatred (disrespect) to increasing care (respect). While reconciliation cannot be forced, it happens between people who experience the forgiveness process (see outline above). Those who report reconciliation also report a greater sense of justice and a greater sense of safety. Respect increases.

## Probation, courts refer cases by hundreds

Referrals were received primarily from criminal justice officials. Most referrals were from Juvenile Probation as a diversion from the court system for those juvenile offenders who are first or second time offenders. VORP also receives referrals on more serious cases from the courts, both juvenile and adult. A few referrals were made directly by the police. And cocasionally we receive a self referral, either victim or offender (these tend to be the most serious cases). VORP is often part of a sanction or sentence but occasionally the sole sanction. VORP received 439 referrals in 1994. Special thanks to all of the criminal justice officials who made referrals or in some other way helped us to do our job. VORP couldn't work without your support.
