Victim Releases Offender From A \$2,000.00 Debt!

Maria Contreras, a 14 year old run-a-way, together with her two friends, Donna and Renee, 14 and 15, stole an electrician's van from a local school. The keys left in the van proved too tempting for them.

After a week of eluding the police and family, the three were apprehended. \$2,000 in damages were later reported to be done to the van and its equipment.

At the VORP mediation, Doua Long, the Project Manager for EFX, Inc., would decide to forgive the \$2,000 debt. The reason: he was thankful for the fact that Maria's mother, Genelle, made the extremely difficult decision to report her own daughter to the police and call the school as soon as she learned what happened. He said for himself and his company this act and the returning of the van was justice enough.

Privately, Doua shared with me that he knew poverty himself, what it can do to people, and the hardships it can create. He also wanted those involved to know God's mercy.

Doua's calm and understanding presence at the mediation spoke loudly to Maria and Genelle. Many times in the meeting you could see how grateful they were for his gentleness and understanding towards them.

Maria had already begun to make changes shortly after the incident. A big motivation for her was that she might be taken away from her family.

Genelle too was making some changes; she wanted to do whatever she could to make herself a better parent and mother. She was also making sure they were

doing all that the court was asking of them.

At the court's review of our mediation, the judge decided to add 100 hours of community service to Maria's mediated agreements.

Maria was still thankful however, because her fears were faced and overcome, first with the victim and then with the courts; she was at peace with the victim and she wouldn't be removed from her family.



VORP helped Maria locate some community service locations. She was given letters of introduction to a local church and a City Council candidate's office. Surprisingly, both Maria and Genelle are now volunteering their time together for this local politician.

It was the kind of forgiveness God is known for — "Our debt paid in full!" — A rare experience in our justice system, and in life.

Amazing things can happen when people are given the freedom to decide for themselves what 'justice' means for them.

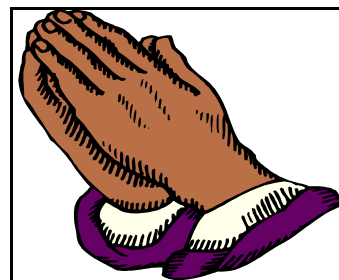
For now, the sincerity of Maria and Genelle will be seen in their actions. If they follow through on their promises, the State will be satisfied, the actual victim of the crime will be satisfied and justice will have been served in our community.

SURVEY OF CALIFORNIA VORP PROGRAMS CONFIRMS BENEFITS OF MEDIATION

In May 2000, the Judicial Council of California released its year-long study of six (6) of California's 26 Victim Offender Programs (VOPs).

The study revealed what VORP and other restorative justice and mediation practitioners have known for years — mediation works!

The study reported that:

1. Youth who participated in mediation were much less likely to re-offend in the future than those who did not go through the mediation process.
2. Youth who went through mediation were much more likely to repay the victim for damages; and
3. Victims who participated were much more likely to be satisfied that justice was done, than those participating in traditional justice processes.
