“Bittersweet Candy, Sweet Peace”

I thought taking a case of candy stealing fifth graders would be a breeze. I thought wrong. What I found was that God was showing me there’s a lot I still had to learn about working with children.

I met with the first offender, Jacob, at his home, attended by both his parents. Jacob said he took the money, but the girls talked him into it. His parents felt strongly that Jacob was coaxed by the girls, but that he should pay his part in this.

I met with Maria and her mother. She was a very intelligent little girl who had a story far different from Jacob. She blamed Jacob for the entire incident. She did tell me, however, that she was willing to work to pay back the school for her part in what happened.

Finally, I met Monica. Of course, she had a story too! Monica’s mother sat crying as she listened to her daughter tell her involvement in the offense. Monica said she felt she had dishonored her teacher and her mother by what she had done.

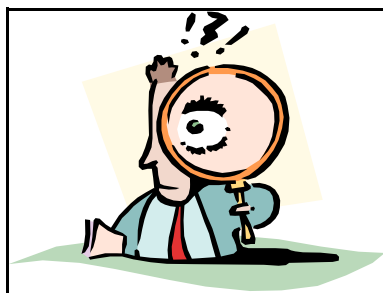
The victim, the Principle of a local Fresno elementary school, was very willing to talk to the children and their families.

Mr. Contreras, the Vice Principal, and I met with the three youth and their parents. The ground rules were laid out with a positive tone, especially how important it would be to tell the truth.

Each of these youth told their

stories of stealing and concealing stolen candy from the “Snack Shack” at their school. And each of their stories, just like the first time, were entirely different.

Mr. Contreras and I requested them to re-tell their stories, this time taking responsibility for their specific part in the offense. Mr. Contreras made sure each of the kids understood what “truth” and “responsibility” meant.



The truth came out that Jacob was the leader in stealing the money. His mother was in shock.

Then Monica told how she and Jacob had made Maria out to be the person who was the leader. Finally, Maria shared her story again. This time the stories matched.

Mr. Contreras told the kids just what kind of impact this had on the school. The missing candy cost \$128.00. The “Snack Shack” had to be closed down for the rest of the school year. And, without these proceeds, there would be no monies to go towards student fees for sixth (6th) grade camp. Their faces saddened as they realized they had just ruined their own chances for going to camp.

Regarding the future, Mr. Contreras expressed how he’d like to see each of these young people succeed in life. He talked with each of them in a personal way. They were very open to his hopes and ideas for them. They were eager to repay the school for what they did.

Each would agree to work an hour-a-day with the custodian, after-school, for a total of 30 hours. At the end of the mediation, Jacob’s mother apologized to the girls and their mothers for blaming them for all of this.

My eyes were opened to see that some situations need a willing heart and an open mind to “find” peace. God helped me to see that I didn’t need to know all the facts. By respecting and caring for people the truth came out, and the people made peace.
